15 out of 25 students or **60%** students got 'C' or better as their final grade.

15 out of 23 students or **65%** students got 'C' or better as their final grade excluding 2 who has withdrawn from class.

21 out of 25 students or **84%** students got 'C' or better as their final grade excluding 2 who has an INC as a Final Grade.
