Agenda/Major Topics of Discussion:

The fce 2015 01 09 minutes were approved as amended.

VPIEQA said that our summit was six months ago, and we must turn in our next report to WASC in three months. The FCE members' role is to assist the writing team in looking for and adding key evidence that is presently not included in the report. We must focus on whether or not we are in compliance with the standards, not whether or not we are happy with the status quo. Meeting standards should be the benchmark, then we can decide what we need to do to improve our college.

The Chair assigned members to continue to work to complete evidence of compliance for the four parts of Standard III.B and report back to FCE on March 6.

- 1, Members at the national site have been asked to focus on III.B1, III.B.2, III.B.3, and III.B.4 as four sub-groups.
- III.B.1 consists of Ringlen Ringlen, Ikoli Ilongo, and Warren Ching.
- III.B.2 consists of Don Buden and Rey Garcia.
- III.B.3 consists of Michael Mueller. I have suggested that he confer with Director Mendiola as no one else volunteered to look at III.B.3.

Others are welcome to join this group.

- III.B.4 consists of Rafael Pulmano working with Director Mendiola
- 2. The state campus members are being asked to review all four of the standards for their campus to be sure there are no gaps on their campus.

They are also being asked, as are the groups above, to inform the writing team of evidence in support of meeting the standards that they may have on their own campus.

- 3. The four sub-groups and state campus groups should have comments, edits, and other input prepared in advance of the 6 March 2015 meeting
- 4. The VPIEQA would like the 06 March 2015 meeting to be dedicated to the thoughtful review of those comments with the writing team/Francisco Mediola (writing team chair). She has asked that Sandy Pond consultant David Adams be allowed to share some materials to guide writing excellent Standard responses and to join that FCE meeting.
