New business

1. One of the major problems at this time is from instructional program and it contributes to low enrollment and delaying of graduations. The degree programs. We have a several courses that the students need to take but there is no instructor for those courses. Some decisions were made by an ad hoc committee. The hiring process is taking too long. Ad hoc makes an appropriate recommendation but then that decision is overturned or delayed until the person is not available. And then the campus does not have an instructor with the desired qualifications.

Response: HR works as quickly and efficiently as possible. HR has to run background check information, these processes take time. Delays are sometimes unavoidable.

The committee is aware that the campus needs ESS and science positions. National campus is facing some of the same challenges. Not only the process that delays this. The applicants sometimes delay the process. Applicants sometimes back out late in the process. The campus might consider looking into the community to seek a part-time instructor to fill the need.

Kosrae notes that the lack of an IC is impeding their ability to work on

obtaining a part-time instructor.
