## **Discussion of Agenda and Information Sharing**

- 1. Quorum was declared at 1:13pm.
- 2. The vice chair received a message from the chairwoman that she was out sick. Vice chair went over the agenda.

## 3. Approval of minutes

The minutes from the meetings on April 21, 2017, September 01, 2017 and October 06, 2017 were emailed to members earlier in the week for review. Although we had said at our September meeting to approve the April minutes online, the officers did not receive any responses. The September meeting minutes were not approved because we had guest speakers at our meeting in October. They went right into their presentations so we did not have time to review and approved the minutes. Jothy moved and Cindy seconded to adopt the minutes from April 21, 2017. Twyla moved and Mark seconded to adopt the minutes from September 01, 2017. Ben moved and Wilson seconded to adopt the minutes from October 06, 2017. All three minutes were approved as is.

#### 4. Finalize TOR

#### 5. Measures of Success

Following VPIEQA's presentation on the Measures of Success (in the 2018-20123 Strategic Plan) during our October meeting, we were to have picked one or two of the measures that she discussed and sent them to our chairwoman. The Measures of Success with the highest pick will be our committee's focus this school year. Only a couple of members sent their responses. We will again review the measures and email to the chairwoman no later than Friday, November 24. Vice chairman reminded everyone on the importance of responding to requests in order for our committee to move forward.

The Dean of Academic Programs shared that instructional programs are working on the completion rate by reviewing the credit requirements and reducing where there are to many.

6. An advisor shared that he encourages students to register early but a problem they face is not being able to because they have an outstanding balance. Twyla clarified that they must first pay at least 10% (current balance) or 80% (older balance) of their outstanding balance before they can register. This is also the same for those who received their award early in the semester but still end up with an outstanding balance. For those who have not been awarded, the Financial Aid Office can indicate that they will be awarded.
