# **Agenda/Major Topics of Discussion:**

## National Campus Updates

- 1. Nothing new has been provided by the Task Force; The declaration is in effect until March 13<sup>th</sup> and we will wait for directives.
- 2. President Panuelo issued a memo stating Hawaii is no longer being a viable option for quarantining
  - a. EMT Chair has requested a copy of the memo for record keeping
- 3. 14-day quarantine is still required in a virus-free state/ nation; only viable option now is Guam before entering FSM.
- 4. Cases in both RMI and Palau were negative
- 5. RMi is on lockdown nobody will deplane or board; only planes are landing for refuel
- 6. Review of worldometers statistics; number of cases continues to increase, but statistical rates of recovery are still very high.

Pohnpei State Update – EMT Chair and CTEC Dean attended the Pohnpei State Task Force meeting last Wednesday, March 4<sup>th</sup>

- 1. State is not ready for a case as we do not have the equipment we need to support the facility; Misko facility is ready to receive patients
- 2. There is worry in the state's ability to contain the virus if it gets here
- 3. It was said in the PSTF meeting that if Guam or Hawaii have a confirmed case, the governor will declare a state of emergency.
  - a. Over the weekend, Hawaii received its first confirmed case so now we are waiting to see if the declaration is made.
- 4. Even if 1 case makes it to the FSM/ Pohnpei, all schools will be closed for fear that the state will not be able to contain the virus.
- 5. If there is a case on campus, we call the state officials and the sate will pick up the person in question

#### Supplies on Hand

- 1. Quotations we have are either for supplies discontinued or not in stock
- 2. Currently on island, Pohnpei has:
  - a. Medical gloves
  - b. 36, N-95 masks at MedPharm (\$6/ piece)
  - c. Rubbing alcohol alternative to hand sanitizer, but is hazardous

- d. A-One Supermart has antibacterial wet wipes (129 available)
- 3. The College currently has 800 masks on hand
- 4. Once ordered supplies arrives (anticipating tomorrow), recommendations will be made for distribution of inventory
  - a. Do we use the inventory now or do we hold it until a case comes to the islands then start implementing use?
- 5. Rain water system has been connected to our water lines.
  - a. Currently waiting for PUC to come and switch the valves to ensure we have continuous water for proper hand washing

### EMT Chair proposed to include Dr. Dacanay in the EMT meetings

- 1. The state has reached out to him to prepare for trainings
- 2. Acting President will contact the Public Health facility to include in our meetings

## **HRO Policy**

- 1. 6B Bullet 3 There is concern with the wording "suspended"; we need to strike that term and use better wording to clarify the point being made
- 2. Anybody with issues to the proposed policy should email Rencelly directly
- 3. EMT will approve policy as a living document and will be submitted to the Board on Wednesday

# Options for Closing the College

- 1. We can go online with courses in an informal setting
  - a. Via email, submit work electronically and professors have to initiate contact
- 2. If we decide to close and not offer courses online, we can request a shortened term
  - a. If doing so, the request goes through the USDOE for approval
  - b. How to process financial aid/PELL is all laid out for us
- 3. Curriculum meeting earlier today discussed alternative options, but we are still waiting to receive feedback from the group.

#### Residence Hall Students

- 1. Options for the students
  - a. Send them home
  - b. Stay in the RH with family authorization
  - c. Give students the option to stay in RH or move out and stay with family or go home
- 2. Risks we take by keeping them on campus
  - a. Cases arrive on island/ on campus
  - b. Risk of food shortage for extended period of time since we do not know how long schools will shut down for.

### **Identified Essential Employees**

- 1. First Responders
  - a. Nurses (Benina + 3 Public Health Nurses)
  - b. Security
  - c. Residence Halls
  - d. Maintenance
  - e. Dining Hall
  - f. Accounts Payable/ Payroll

- 2. EMT Chair has called a meeting with Benina, RH and security to prepare the First Response Team for National Campus
  - a. Will identify a campus quarantine location
  - b. State will come in and prepare the facility after the location is identified
