- 1. RAR meeting started at 1:10pm, hosted and welcomed by the Vice Chair, followed by moment of Silence and reading of mission statement.
- 2. By 1:13pm Quorum established with 11 members present.
- 3. Adoption of December minutes unanimously voted by the members.
- 4. The Vice Chair open the discussion and give the floor to the Registrar; the Board Policy No. 4004 (Open Admission for Non- Credit Courses) explained and discussed with members. Member from National campus raised a question regarding the payment, and the Registrar fully elaborate on possible scenarios such mutual agreement between parties, grant (if any) and the college. Same member also commented on the second to the last sentence of the board policy, (When offered, information is disseminated through the radio, TV and printed notices in various places) if possible to add poster, websites, newsletters, news feeds etc., and has been move to adopt with suggested amendment, and unanimously voted by the members. The second sentence of the Board Policy No. 4004 reads: "When offered, information is disseminated through the radio, TV, College website, and social media, and printed notices such as posters and other available means of publication".
- 5. Board Policy No. 4005 (Identification of Students), Vice Chair allowed the Registrar to discuss further this policy. Financial Aid identification were discussed along with the category being used by the College under this policy as fulltime student for more than 12 credits & more than 6 credits in summer and part time student with less than 12 credits regular semester & less than 6 credits in summer. Members reviewed, and discussion was made to retain this policy as is with no changes. It was unanimously voted as is.
- 6. The Vice Chair explored with the members any miscellaneous issue to discuss. The Registrar opens the upcoming COMET testing. Due to current locked down and the threat of Covid -19, COMET might be cancelled depending on the current situation until the 25<sup>th</sup> of this month. If no further threat, schedule will proceed as is, but if not, IR should discuss other alternative way. Chuuck campus member also commented and seconded to find alternatives as soon as possible. Furthermore, the Registrar requested to include COMET schedule in the next meeting to discuss further alternative, if the situation worsen. Members unanimously accept and no further comments.
