#### Discussion of Agenda and Information Sharing

1. Committee meeting started @1:05pm, hosted by the officers, and welcomed by the Vice Chair.
2. By 1:15pm quorum established with 12 members present.
3. The chair welcomed the members, followed by the moment of silence, and reading of mission statement by the Vice Chair.
4. Adoption of January minutes unanimously voted by the members.
5. The chair opens the discussion and give the floor to the vice chair on behalf of the Registrar, and explained the Board policy 4100 (COMET Entrance criteria); discussed the components of two main criteria (main

entrance and alternate criteria). A member from the National campus shared her thoughts to update this policy since revision was made in 2014. The chair elaborated that this policy still current as no recommendation from the OAR for any changes. There were no comments from the members, and the motion was moved by the National Campus member to adopt this policy as is and unanimously voted by the members.

6. The vice chair continued to discuss and elaborate the Board Policy 4201(Special Consideration), is applicable to those students from high school with GPA below 2.0, will not be admitted to the college unless their job experience or training is considerable and recommendation is issued by employers or agencies. COMET scores will be taken a consideration, through recommendation of this committee, the COM President approves. The chair clarifies if this case is the same as non-traditional students who wants to come back and attempts college. The vice chair explained that this policy is for none admit students from high school with intensive training & experiences. This policy needs to be reviewed and must be specific regarding reasons for employment or what academic background does this applies. Another member from National campus commented that registrar needs to explain this further, as this case is rare, may be happens every 3-4 years or sometimes never happen. Thus, leave it to the President to look at it, evaluate and decide. No further discussion and comments from other members, no changes made in this policy.
7. The chair opens the floor for any Miscellaneous. The vice chair raised the issue about composition of the committee members, if OAR representative could be a member across the college, and the chair confirms the members who are OAR representatives currently in the committee, just a matter of “reactivating” them. Another issue discussed was the attendance, for the past meetings many were absent and for the first time this month, some members emailed their valid reasons of not being able to attend this meeting. Several members have not attended the meetings for more than 3 times without reasons. Furthermore, the vice chair suggested to look upon the time conflict of COMET in the committee’s meeting schedule. As his time of the year, most of the members cannot attend the meeting due to the test. The chair explains, maybe the next officers can consider the events to avoid conflict of schedule, and it’s all up to the officers to come up with flexible schedule. Other matters discussed were technical difficulties in uploading the minutes, agenda to be included in the next meeting (such as COMET results), and upcoming election for the next set of officers.
