Discussion of Agenda and Information Sharing

- The meeting was called to order at 1:06pm with a moment of silence and reading of the college mission statement. Roll call was done throughout the meeting with sixteen (16) members and one (1) additional attendee present.
- The committee went on to review the Quality Focus Essay for comments and/or recommendations. The registrar gave a brief explanation of the document, informing the committee that the document is based on past data gathered from various studies and surveys done at the college. It was noted that the hyperlink for the "action plan" was not working so that the registrar will work with the writing committee to fix that part of the document. It was then moved and seconded to endorse the document. All were in favor of endorsing the document.
- Board Policy 3104 was formerly titled Credit by Examination. A brief background was given by the registrar stating that a team was formed by the Interim-President to work on the policy which is now titled Prior Learning Assessment. As opposed to the former policy which was general and not very detailed and specific, this policy now includes detailed and more specific definitions of how credit by examination is reviewed and done and how prior learning is equivalent to some of the courses in each program. The team looked at prior learning policies from different colleges and universities to find one that is more applicable to COM-FSM. The RAR committee was asked to review the modified policy and provide comments, recommendations, if any, and endorse. There were no inputs other than commending the writing team on the policy. It was then moved and seconded to endorse the revised policy. All members were in favor to endorse revised policy.
