Renovation and Improvement of dorm showers and toilets (male and female dorms)

Contract made on the 5th day of May 2010, by and between College of Micronesia - FSM, herein referred to as Owner and "Pacific Landscaping, Engineering & Construction, Inc.", herein referred to as "Contractor".

Whereas COM-FSM contracted Gonzales General Construction Co. provide material, equipment and skilled labor for the renovation and improvement of dorm showers and toilets (male and female dorms) per attached "SCOPE OF Work".

TERM

Duration of services to be performed under this contract shall commence upon <u>issuance of written NTP</u> and shall be completed within <u>45</u> calendar days. Liquidated damage in the amount of <u>\$25.00</u> will be assessed for each day the project is delayed.

COMPENSATION

Subject to deductions as required by or as provided in this contract, Owner will pay contractor a total of **Eighteen thousand**, six hundred dollars and no cent (\$18,600.00) during the term of the contract.

Payment to the Contractor will be made when CONTRACT is certified or approved and apportioned as follows:

Warranty

The contractor warrants that all work done under the contract will be of good quality and in compliance to construction standard. Work performed not conforming to these requirements shall be redone by contractor as requested by the COM-FSM. A Warranty period of 180 days or six (6) months shall be assessed for this project.

TERMINATION OF THE CONTRACT

The Contract may be terminated by the Owner for any of the following reasons:

- A. There is substantial evidence indicating that the Contractor has neglected or discontinued to perform any part of the scope of services approved in this contract;
- B. The Owner feels and determines that the Contractor's performance is unsatisfactory and may compromise the integrity or quality of the project.

Dispute

Both parties agreed that the Jurisdiction for any legal action brought pursuant to the terms and conditions of this contract shall only be in the FSM Supreme Court in the State in which the project is held.
