## **Discussion of Agenda and Information Sharing**

The fact that a new set of questions was used was discussed as possible reason for the negative results. It was recommended that the stakeholder submit a request in writing for RARC review and action.
- 2. The committee needed clarification of the CAC Recommendations for Admissions Criteria and invited DAP Karen Simion to its meeting. After DAP's clarification and discussion among members, it was decided that a working group be formed to work on the admissions criteria.
- 3. President Daisy joined the meeting later to discuss the notion that the COMET was the only admissions criteria used by the college. A notion that most of the COM-FSM community, a member of the BOR, and other stakeholders had. It was clarified by the President that there was confusion and it has been resolved. Other admission criteria apart from the COMET do exist.
- 4. Due to the very informative discussions, the election of new officers for SY 2013-2014 was tabled to a special meeting scheduled on Thursday the 9<sup>th</sup> of May from 10am to 11am.
