Discussion of Agenda and Information Sharing

- 1. The meeting began at 1:15 because of technical difficulties with the VOIP.
- 2. May 1st and May 9th minutes were reviewed and adopted by a unanimous vote by the members of the committee who were present that day.
- 3. Chairperson Lucia Donre announced the meeting schedule for this semester once a month, on every Wednesday of the last week of the month, unless deemed necessary for a special meeting, then Chair will let other members know ahead of time.
- 4. A concern was raised by member Jeffrey Arnold about the results of the COMET this year. Mr. Arnold asked if the College could find a way to inform the community of the reasons why there was a tremendous decline of the passing students for this year's COMET.
 - a) Chair responded that a letter was already sent to a governor responding to their concerns about the COMET. Members of the committee also asked if the letter can be viewed by the RAR committee if it's a public letter and be made public to stakeholders and other entities for awareness purposes.
 - b) The committee was also reminded of Karen's visit and President Daisy's for clarifications of questions regarding the COMET results.
- 5. Member Dokowe George raised an important issue with the possibility of having state campus proctors administering the COMET because of transportation issues.
 - a) The committee discussed the issue and was reminded again about confidentiality issues and decided to make a recommendation to the administration to keep TAs open for proctors administering the COMET in Kosrae.
- 6. Rhoda Velasquez suggested that the College should have a reviewer/tutor for all high schools to help them better prepare for the COMET.
 - a) The committee was then reminded of the practice tests available on the website and should be made known to the high schools and anyone who wishes to take the COMET.
 - b) The committee then decided that since the reading comprehension was changed, the practice tests should also be updated. Member Francisco Simram moved and was seconded by Amy Delyla Ulm that a recommendation should be submitted to Karen Simion (DAP) and Ross Perkins (Assessment Coordinator/Assisstant to VPIEQA) to see to it that an updated practice test is made available online for the Reading comprehension section of the COMET. The committee voted and it was unanimous.
- 7. The committee was reminded of the next meeting (September 25, 2013) and meeting was adjourned at 1:55 pm.
