I: The Chairperson called the meeting to order at 2:20pm Pohnpei/Kosrae Time and 1:20pm Chuuk/Yap Time followed by a Moment of Silence lead by Chairperson. The Mission Statement was also read by Chairperson.

II: The Roll Call was made by the Secretary through which he indicated that 10 out of the 33 members were present which meant that there was a quorum. (More members logged on while the meeting was ongoing)

III: Adoption of the April 28<sup>th</sup>, 2023's Special meeting minutes was adopted via online e-mail and confirmed on Wednesday, May 3<sup>rd</sup>, 2023.

IV: The Chairperson then proceeded onto the Adoption of the Agenda of the meeting which was unanimously adopted by members present. There was a motion made by Chairperson that the agenda be adopted and it was seconded by Yap Campus representative.

- 1) The first item on the agenda was Ex-Officio's updates. Unfortunately, Ex-Officio was not present to conduct his report. However, he met with Secretary via Student Life Virtual Page prior to the meeting to report on his behalf, thus the updates are as follows:
  - The Office of Student Life will be closing out the Assessment year and that should any of the Campuses that have not submitted their Student Activity's Purchase Requests and other financial activity documents, will need to do so to the Office of Student Life or to the Secretary of the Vice President of Enrollment Management and Student Services as soon as possible.
  - On May 15<sup>th</sup>, 2023, the Office of the Student Life will be hosting a Close Up Program College Tour to a total of 41

High School students from the Marshall Islands and the Pohnpei Christian High School. Thus, the Acting Director of Student Life Mr. Loatis Seneres is planning to have the tour broadcasted online via Zoom for the other Campuses to view and participate.

- National and CTEC Students will have a Dance Night on Friday, May 12<sup>th</sup>, 2023 at the National Campus China-FSM Friendship Center Gymnasium from 6:00pm-10:00pm. There will be awards for Best Couple, Best Dancers, Best Dressed.
- Yap Campus also announced in the chatbox that SBA Officers will host a movie night on Friday, May 12<sup>th</sup>, 2023 as well.
- Lastly, the Acting Director of Student Life encouraged all Campuses to begin recruiting in the Summer for prospective SBA Officers to hold offices for Academic Year 2023-2024 beginning with elections in the first week of September 2023 and the new SBA Officers being sworn into office afterwards.
- 2) The next item on the agenda was further discussions on Canvas Orientation and solutions/information gathering with which the Chairperson indicated that there is no more further discussion on this matter as it was covered on Friday, April 28<sup>th</sup>, 2023's Student Success Committee Meeting.
- 3) The next item is the selection of New Student Success Committee Officers for AY 2023-2024. The Chairperson opened the floor for any nominations beginning with the following:
  - a) Chairperson- There was a nomination from Kosrae Campus nominating Secretary Wilson Bisalen to once again become Chairperson. Current Chairperson Mr. Tendy Liwy Seconded the motion and while Yap Campus representative closed the nomination process as well for Chairperson. Thus, the wing to confirm began resulting in a unanimous decision of 10 members that were in attendance to confirm that the Chairperson for Academic Year 2023-2024 will be Wilson Bisalen.
  - b) Vice Chairperson-The current Chairperson yielded the floor to the current Secretary to begin the nomination process for Vice Chairperson. Current Chairperson nominated current Vice Chairperson Mr. Skipper Ittu to continue his role for the 2023-2024 year. There was a motion to nominate Vice Chairperson Mr. Skipper Ittu from Kosrae Campus in which Kosrae Campus representative seconded the motion with which the CTEC representative closed the motion. There was then a voting to confirm which all 10 members that were in attendance unanimously confirmed that current Vice Chairperson Mr. Skipper Ittu continue his role for the 2023-2024 year.
  - c) Secretary- The nomination of Secretary was opened thus, Yap Campus representatives (including the Yap Campus SBA Officers) nominated current Chairperson Mr. Tendy Liwy. Chairman Liwy declined the position. Current Secretary nominated Ms. Monalisa Layan (Yap Campus Representative) which Chairperson seconded the motion as well as closed the nomination and confirmed with the support of all 10 members present that Ms. Monalisa Layan from Yap Campus be the new Secretary for the Student Success Committee for 2023-2024 year.
